



SELF-NOMINATION INSTRUCTIONS AND FORMS

IAIA 2022 Board of Directors Election

1. Review and sign the “Confirmation of Commitment to IAIA Board of Directors” (page 2).
2. Gather at least five signatures of current IAIA members to formalize your nomination (pages 3-4).
3. Prepare a short bio, no more than 250 words in length, containing: a brief overview of your professional qualifications and experience; a brief statement of any current or past service to IAIA; and a short statement of your ideas or suggestions for how you would like to see IAIA develop during your term. The bio is best written in 1st person, as it is included on the ballot to assist members when making their voting choices.
4. Include a headshot/photo to accompany your bio on the ballot. A high resolution photo in .jpeg format is preferred.
5. Submit the above items (signed Confirmation letter, five nominating signatures, 250-word bio, and photo) to the IAIA Executive Director and the Board Nominations Chair no later than **Friday, 19 November 2021:**
