## INTERNATIONAL ASSOCIATION FOR IMPACT ASSESSMENT

### SIGGAS Incorporation of the Environmental Dimension in Gas Pipeline Siting

SIGGAS is a computational tool that uses GIS methodology in gas pipeline corridor selection in Brazil.

The methodology is based on overlapping thematic maps, where each theme (layer) corresponds to a set of spatial features. The degree of restriction/attraction of a spatial feature is represented by an impact score, which is the proportion of the potential pipeline impact to the spatial feature considered. Using Total Accumulated Surface and the sum of the layers selected, alternative pipeline routes are evaluated and selected to minimize environmental impacts.

The GIS distance module is used to obtain the area of smallest impact scores between pipeline termini. Based on this method, CEPEL (Eletrobrás Electric Power Research Center) developed a tool to automate the definition of the corridor location of pipelines. The tool allows monitoring of impact scores given to valuation elements and weighting of different layers. Inclusion of engineering restrictions and consideration of predetermined pipeline vertices in the route are being developed.

### Evaluation of Cumulative Impacts in Hydropower River Basin Inventory Studies in Brazil

Brazil possesses considerable hydro-based generation capacity. In 2007, Brazil's hydropower potential was approximately 246,133 MW; 28% is in operation, but 30% still requires an inventory study (79% of this is located in the Amazon Basin).

Hydropower River Basin Inventory Studies occur at the start of the planning process for electricity expansion, when resources are not yet committed to future hydropower facilities in a particular river basin partition. This is the ideal moment to study all alternatives and select one that presents the best energetic and social-environmental efficacy. Alternatives analysis aims to maximize economic-energy efficiency and minimize negative social and environmental impacts, considering also cumulative effects and positive impacts from multiple purposes such as energy generation, irrigation, and flood control.

The methodology and analytical procedures for Inventory Studies are described in the *Hydroelectric Inventory of Hydrographic Basins Manual*. The approach presented in the Manual and the Computation System (SINV) that uses a Windows graphic interface to aid multi-objective analysis for selection of river basin hydropower partitions were developed by CEPEL (Eletrobrás Electric Power Research Center). ### EU Study on EIA and SEA Directives

The European Commission (EC) recently commissioned a study on the implementation and effectiveness of the European Union (EU) Directives on environmental impact assessment (EIA) and strategic environmental assessment (SEA). The Directive on EIA was published more than twenty years ago, and there has been considerable practice meanwhile, whereas the Directive on SEA only fully came into force in 2004. The requirements of both Directives have been implemented in a different way by Member States, as the Directives set only the procedural framework for EIA and SEA processes. The EU study covers all 27 Member States and is aimed at supporting the EC in reviewing and updating both Directives, and potentially merging them into a single Directive on environmental assessment. # ••• From the President



## A Cumulative Effect of Conducting IA in a Society

This year is the 40th anniversary of the U.S. National Environmental Policy Act (NEPA). The first EIA system in the world was created under the Act, and the concept and methods of impact assessment have since prevailed all over the world. It has been 40 years since the article “The Tragedy of the Commons” by Garret Hardin appeared in the journal *Science* in 1968. Now we are facing the tragedy of commons of climate change, the negative effect of accumulation of human activities on the Earth.

On the topic of cumulative environmental effects, IAIA held a very successful meeting in Calgary, Canada, in November. About 350 participants gathered there and exchanged their experiences and diverse information on managing and assessing cumulative effects. The first snow of this winter in that area welcomed the delegates. It was nice, as they could have cool heads while they conducted hot discussions.

The topic of the meeting could have dated back to the early ‘70s in the U.S. It was a problem of accumulation of mining in the northern part of the US. The same thing also happened Canada. This type of problem had already been posed in “The Tragedy of the Commons.” Hardin argued that an environmental problem is essentially a population problem. It was a very influential article at that time, and many discussions followed. Hardin warned of cumulative effects from human activities on the environment, calling the negative situation the tragedy.

Today we are facing an emerging tragedy of the commons, that is, “climate change.” Climate change might be a problem which Hardin identified with no technical solution; he insisted that the answer to this class of human problems could not be found in science and technology, but only in the mind of the people.

What do you think? Can we ameliorate cumulative environmental effects without changing the mind of the people?

I would like to point out the educational function of IA in a society in this context. IA is a communication process to provide information and knowledge for sustainable development. The information and knowledge provided in the process of project EIA is very concrete, but quite narrow for awareness of sustainability. Successful SEAs should be more effective in explaining cumulative effects and considering sustainability.

IA should work as a measure not only for supporting decision-makers but also for enlightenment and education of the people. IA has been conducted in many countries and regions in these four decades, and the concept of sustainable development has been gradually shared. This is a cumulative effect of conducting IA. I think that we could expect to build consensus among the public to have a policy towards more sustainable direction by changing the mind of the people. This is to create “Heart-ware” among people.

## Washington Area Branch of IAIA Participates in Meeting at Canadian Embassy; Focus on Climate Change

The Washington Area Branch (WAB) of IAIA participated in a presentation and reception at the Canadian Embassy on 18 November. The occasion marked the start of a trade mission of Nova Scotia companies showcasing climate change tools and technologies and coinciding with the 9th International Conference on Greenhouse Gas Technologies held in Washington DC from 16-20 November 2008. Major new directions for current global climate change strategies by international financial institutions were provided by Kseniya Lvovsky, Program Manager, Climate Change, World Bank, and David Wilk, Director, Sustainable Energy and Climate Change Initiative (SECCI), Inter-American Development Bank.

Climate change from an IAIA perspective was presented as a global “Tragedy of the Commons” which will result in significant cumulative impacts throughout the 21st Century. **Norval Collins**, an IAIA member from Nova Scotia, made the point that Canada is uniquely positioned to address climate change issues as a major energy exporter and consumer, and due to major changes occurring as a result of climate change in Canada’s North. Collins, president of CEF Consultants, briefly described several activities underway in Canada and internationally by climate specialists Cameron Ells from Cameron Consulting and Zoë Caron from Zerofootprint Inc. Robert Niven, President of Carbon Sense Solutions, described the need for new technologies, stressing the current emphasis on carbon capture and the pilot project being launched in Nova Scotia in cooperation with Dalhousie University. Other Canadian technology companies participating were LED Roadway Lighting, Stantec Consulting, and Trijac Geological Consulting.

The insightful discussions were followed by a delightful reception hosted by the Canadian Embassy.

## NZAIA Annual Meeting Focuses on Coastal and Lake-Front Environments

The New Zealand Affiliate of IAIA, NZAIA (New Zealand Association for Impact Assessment), held its annual conference 27-28 November in Nelson, a small town at the northern end of the South Island, set on a beautiful bay and basking in warm sunshine—a very apt location for this year's theme: "Assessing Impacts on Coastal and Lake-Front Environments." The conference was enjoyed by just under 50 participants.

For 3-4 years we have been running our meetings using a specific model: we decide a particular topic (last year urban growth, the previous year energy development), we have only invited speakers, and we try to ensure plenty of time for discussion to make more of a workshop environment for participants. The emphasis is on providing high-quality information on recent case studies, new methods, or just current challenges facing impact assessors, and we attract a broad practitioner audience: planners, resource managers, consultants, researchers and academics.

This year we opened with a talk from Prof. Nick Harvey, University of Adelaide, whom many know from his EIA work in Australia and Asia, but he also specializes in coastal geomorphology and coastal management. Harvey brought valuable lessons from South Australia, in particular, for the New Zealand practitioners to compare with their own experiences. The main programme then covered strategic concerns, specific issues involving land, marine and lacustrine activities and their impacts, community engagement and partnerships, and monitoring.

One of the striking things about this year's conference was the degree of connection made between participants who normally attend separate conferences in their own disciplines. Because the problems of development in coastal and lake-front environments involve all aspects of environment, at varying spatial and temporal scales, they require integrated approaches, both to the assessment of impacts as well as managing the solutions. Participants from very different backgrounds found this conference was of a kind, and a size, that really promoted discussion with each other.

## Impact Assessment Follow-Up, Myth or Reality? 3rd Annual Portuguese Conference on IA Promoted by IAIA-Portugal

The 3rd National (Portuguese) Conference on Impact Assessment (CNAI'08) was held 22-24 October 2008 in Beja. This event was promoted by the IAIA Portuguese Affiliate, APAI (Associação Portuguesa de Avaliação de Impactes), in partnership with EDIA, S.A. (Empresa de Desenvolvimento e Infraestruturas de Alqueva – Company for the Development and Infrastructure of Alqueva) and the Polytechnic Institute of Beja).

CNAI'08 was attended by 180 participants. The 3-day conference program included opening and closing sessions; 13 technical sessions presenting 8 guest speakers, one of them **Iñigo Sobrini** from the Spanish EIA association; 41 papers; 26 posters; and 2 technical visits.

In addition to the focus on Impact Assessment Follow-Up, Strategic Environmental Assessment was also one of the most debated themes. Water Management and Cultural Heritage were other issues discussed with the presentation of several case studies. A dynamic session on public participation was one of the innovations of the conference.

Beyond technical debate, the conference was also the occasion for less formal moments, with technical visits on hydraulic infrastructures and archaeological sites under excavation. The conference dinner delivered cultural heritage, hosted in the beautiful Pousada de S. Francisco, a restored convent of the XIII Century and closing with a performance by the famous taleteller Jorge Serafim.

Two awards were delivered during the dinner: 2008 "Best EIA Non-Technical Summary," for the Non-Technical Summary Report of the EIS "Valley of the Relvinha," prepared by VISA Consultants to PEDRA-MOCA; and CNAI'08 "Best Poster," for "Environmental impact assessment: the process of post-assessment in LIPOR II," authored by Paula Mata, Miguel Coutinho (IDAD, Institute for Environment and Development) and Carlos Borrego (University of Aveiro).

CNAI 4, in 2010, will be co-organized with the University of Trás-Os-Montes e Alto Douro and will be hosted in the university campus, located in the city of Vila Real, in the beautiful region of Douro, a cultural landscape classified by UNESCO as world heritage. ## North American HIA Workshop Held

We are pleased to announce the success of the first ever North American HIA Practitioners' Workshop, held 24-26 September 2008 in Oakland, California, USA.

The workshop, which was attended by 20 participants from the USA, Canada, Jamaica and—surprisingly—Australia, focused on evolving the practice of HIA in the Americas and on identifying unique regional attributes.

Through individual presentations, break-out sessions and whole-group discussions, participants were able to a) develop a list of challenges that HIA practitioners face in the areas of values and principles, regulatory integration, and evidence and analytic methods; b) summarize key areas that needed attention; and c) develop a list of action items to move the field forward.

*Notably, the use of PowerPoint was banned—a strategy that we highly recommend to other groups seeking to foster dialogue!*

Small groups are continuing to work on the identified issues, and will be reporting back to the whole group periodically.

Overall, this was a very rewarding and rejuvenating experience. Many participants had commented that they felt isolated, as there are so few HIA practitioners in the Americas. One of the greatest successes of the workshop may have been the opportunity for collaboration and sharing that it fostered.

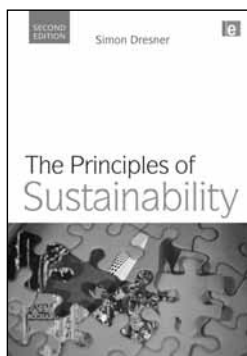

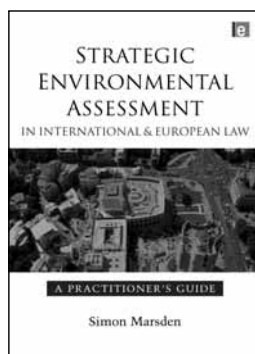

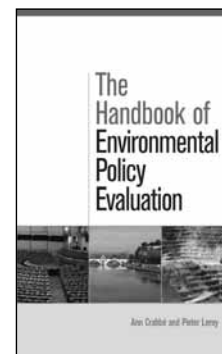
