## International Association for Impact Assessment

### From the President

The IAIA Board has taken a significant step in securing the future growth and influence of IAIA. Under the initiative and leadership of incoming President Mary Lou Morris, a needs analysis was conducted regarding the current status of funding and other support of the Executive Office and its institutional arrangement with North Dakota State University. The objective was to ensure, in Mary Lou's words, "... first-rate administrative capacity to enable increasingly effective development of IAIA priorities."

The resulting "impact assessment" compared three alternatives.

- The first was a no-action alternative to maintain the status quo by retaining the existing administrative arrangement of part-time staff operating through the university's offices and reporting/payment systems.
- The second was to increase staff to full time, but otherwise maintain the status quo.
- And the third alternative was to strengthen resource capacity of the IAIA international administration base. This included attainment of fully independent office facilities and equipment as well as staff salary, development opportunities, and job security to allow for full-time employees of IAIA who could then provide unencumbered IAIA services.

The Board opted for the third alternative, balancing the cost increase with these ad-

vantages of providing full time support status to the Executive Office:

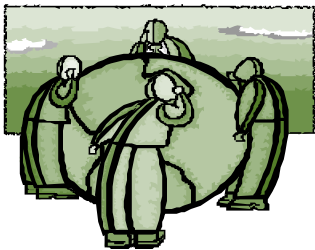
- acknowledges and provides resources to meet the Executive Office's demonstrably increased workload in terms of growing number of Affiliates, strategic alliances, initiatives, donor support and related networks
- recognizes and rewards the enormous contribution of the Executive Office's three principal employees and provides a more stable professional development path within IAIA
- ensures retaining the services of our current highly-trained, valued, and committed staff
- enables a more realistic offer to applicants for the recently-vacated database manager position
- increases staff resources by eliminating work obligations external to IAIA
- gains essential equipment assets and secures 100% access to these basic tools

This is a significant step in the history and growth of our organization. The Board will soon complete this phase of IAIA's strategic planning process and develop an action plan to insure that we attain our goals. In the meantime, make your plans to participate in IAIA'00 Hong Kong—"Back to the Future."

## Continued Internationalization of IAIA Membership

The generous three-year Capacity Building Grant (CBG) provided to IAIA by The Netherlands closes in December 1999. The grant helped internationalize IAIA membership, one of the major goals of the organization. Several IAIA members have expressed their gratitude to The Netherlands for the support and recognize that much work still needs to be done for the goal to be fully met. This can be achieved only if other donors and international organizations are creative in providing similar grants or incentives to EIA practitioners from "developing countries" and countries in transition to participate in IAIA activities and the annual conference.

To continue this process, I suggest two simple initia-

tives for IAIA members to ensure the IAIA goal to further internationalize its membership is met.

The World Bank offices in developing countries of Africa, Asia, Central and South America are involved in most of the economic development projects in these countries, and all projects have an EIA component to them. Therefore, many of the thirty-four EIA practitioners who were grant recipients and attended IAIA'99 in Glasgow, Scotland, worked directly or indirectly for the World Bank. World Bank loans, therefore, could include provisions for membership to IAIA and attendance at the annual conferences for every EIA practitioner in each developing country. This would enable the World Bank EIA staff and

other EIA practitioners in the country to remain part of the IAIA network.

Embassies of countries in Europe, the United Kingdom, Australia, Canada and the United States have a Commerce Section that negotiates trade agreements every day with developing countries. These trade agreements should include provisions for EIA practitioners in the country working on the specific projects for IAIA membership and attendance at the annual meeting.

Imagine the wonders this would work for IAIA and what the profile of IAIA'00 would look like!

## Who's Who in IAIA: Markus Eggenberger

*Continuing our new series profiling IAIA members, this issue we feature Markus Eggenberger, IAIA Council member and IAIA liaison to the UN in Geneva and the International Society of City and Regional Planners (ISoCaRP).*

Markus is a spatial planner and senior researcher with the Institute for Local, Regional and National Planning at the Swiss Federal Institute of Technology (ETH Zurich).

Markus joined IAIA in 1990, and has since worked on several committees and participated regularly in IAIA's annual conferences. As a member of the International Cooperation Committee, he is supporting a stronger visibility of IAIA on an international level.

Markus has a masters degree in forest engineering and is a postgraduate in regional and urban planning,

both degrees obtained from the ETH Zurich. His research interest focuses on integrated planning approaches and decision-making related to sustainable development patterns. He is currently involved as project manager in a training and research project on sustainable urban development in China.

A key issue that Markus believes IAIA should address is the increasing compartmentalization of EIA: "What in earlier times was "just" EIA is now a wide range of tools: SIA, Health Impact, Risk Assessment, etc. Although these are all part of a family, they are presenting themselves more and more as "single" elements. This might be a consequence of the rising complexity with which we have to deal in planning and decision making, but it certainly doesn't make it more simple in selling this tool. The challenge for us is to find some way of

achieving true integration of impact assessment (economic, social and environmental) into the decision making process—from the national to the local, from public to private and from more conceptual down to the concrete project. In this context, Maria Partidario and I are initiating an international study on developing a framework to assist the integration of environmental, social and economic issues in spatial planning."

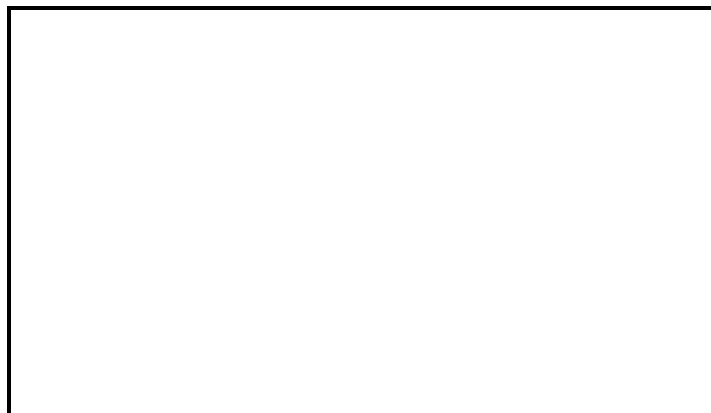

## IAIA Meeting in Montréal

In keeping with the "much-loved tradition" started just last year when the IAIA Board met for its midyear meeting in conjunction with IAIA's annual meeting in Drakensburg, South Africa, the IAIA Council and Board met from 18-23 November 1999 in Montréal. The *Association québécoise pour l'évaluation d'impacts* (AQEI), IAIA's Quebec affiliate, extended the invitation to the Board to come to Montréal for its annual mid-term meeting. The dates of the Board's visit coincided with AQEI's annual meeting. The invitation was accepted. AQEI, its neighbor—the Ontario affiliate, OAlA, Ontario Association for Impact Assessment), and the Francophone Secretariat of IAIA

(also located in Montréal) were all hosts to the IAIA Board. By meeting in Montréal, four organizations were brought together in a way that would never have happened otherwise. All participants gained new appreciation for each other's role in improving the practice of impact assessment.

IAIA board members also had the opportunity to visit faculty and students at four Montréal Universities: University of Montréal, Concordia University, University of Québec at Montréal, and McGill University. And the Francophone Secretariat organized a meeting between the IAIA Board members and representatives of The Secretariat of the Con-

vention on Biological Diversity, the World Conservation Union (IUCN), the E7 Network for Environment, and Montréal International.

The IAIA Council and Board had many quality hours to devote to IAIA business, and extends its gratitude to all who made this possible, including sponsors Hydro-Québec, Ministère de l'Environnement du Québec, Environment Canada, AQEI, 5th Francophone Secretariat, and Montreal International.

Special thanks to Peter Leonard for coordinating the meeting and to Bill Jones for facilitating the IAIA Board's strategic planning session.

## Let's Get Serious

*Article III, Section 3* of the IAIA By-Laws revised and accepted at the Annual General Meeting in Glasgow states that "applications for membership shall be submitted, together with payment of current dues and a *statement of acceptance of the code of ethics*, to the Executive Officer."

In keeping with the intent of this revision to the By-Laws, you will find the code of ethics reprinted on your membership renewal form and on future membership application forms. Please remember to indicate your acceptance of the code of ethics when you send your membership fee payment to the Executive Office. We will also provide forms independent

of the membership/renewal application form from time to time. Our goal must be 100 percent compliance.

The code of ethics for IAIA members (last revised 7/97) states:

- 1) The member shall carry out his or her professional activities, as far as possible, in accordance with emerging principles of sustainable development and the highest standards of environmental protection.
- 2) The member shall at all times place the integrity of the natural environment and the health, safety and welfare of the human community
- 3) The member shall ensure the incorporation of environmental protection and social or socioeconomic impact considerations from the earliest stages of project design or policy development.
- 4) The member shall not conduct professional activities in a manner involving dishonesty, fraud, deceit, misrepresentation or bias.
- 5) The member shall not advertise or present the member's services in a manner that may bring discredit to the profession.



## News from the Francophone Secretariat

### World Bank Environmental Assessment Sourcebooks

The Francophone Secretariat was commissioned to publish the translation of the World Bank's Environmental Assessment Sourcebooks (1991). The French version, entitled *Manuel d'évaluation environnementale*, includes most of the updates delivered by the World Bank since 1991. The *Manuel* gives practical information

on Impact Assessment in general and guidelines and policies for projects financed by the World Bank.

Previously, a draft translation had been made with funds from the Swedish government. The Secretariat finalized the translation and the text was validated by a team of twelve specialists from North America, Africa

and Europe, coordinated by Dr. Michel Bouchard from the University of Montréal.

The *Manuel* (three volumes) is available upon request from the Francophone Secretariat. It is free, but postage must be paid in advance in Canadian dollars. In Canada send \$10.00Can; for international send \$25Can.

### The International Meeting of Francophone EIA Professionals in Paris, France

The *Ministère de l'Aménagement du Territoire et de l'Environnement* of France will be the host of the 5th International Meeting of Francophone EIA Professionals, which will be held in Paris 22-24 May 2000. The main theme will be Strategic Environmental Assessments (SEA).

Many Francophone professionals' recent works in im-

pact assessment revolve around SEA issues. In fact, it is one of the most important developments in the EIA field throughout the world.

Topics to be addressed include the contribution of SEA to EIA policy, institutional aspects, the drawing up of legislative and regulatory frameworks, the fields and contents of SEA, the link with project assessment and

the conditions for public participation. Along with the main theme, other topics to be discussed are scoping, public participation, follow-up and case studies.

A call for papers has been distributed requesting abstracts to be submitted by 12 February 2000. The Secretariat will report on this meeting at IAIA'00 in Hong Kong.

## Back to the Future

The preparation of IAIA'00 is well underway. A number of interesting plenary and workshop sessions are now being developed, covering major key issues such as trade, sustainability, human health, indigenous knowledge, public participation, EIA systems and so forth. More sessions will be developed in the months ahead.

IAIA'00 is about our common future: the vision of impact

assessment and the road maps to get there. This visioning process has already started, with Robert Goodland kindly taking the initiative to involve IAIA past presidents in compiling a document on "IAIA Past Presidents' Vision of Impact Assessment" for presentation in Hong Kong.

Some IAIA Sections, such as Indigenous Peoples and Health, have already gotten themselves organized to de-

velop workshop proposals and their visions. We encourage and welcome all IAIA Sections to start thinking about the visions and contribute to the discussion at IAIA'00.
