**Austrian Act on Transport S(E)A**

The Austrian "Federal Act on Strategic Assessment in the Transport Sector" came into force in August 2005, implementing the EC Directive on strategic environmental assessment (SEA) regarding federal transport plans and programs. The word "environmental" is intentionally missing from the Act's title, as the Federal Ministry of Transport, Innovation and Technology explicitly lists in Article 5 social and economic objectives among environmental ones.

The Act approaches a model of a sustainability or strategic assessment (SA), and contributes to the discussion whether an integrated assessment or an environmental one is preferred. Unfortunately, the Act does not cover the Austrian Federal Transport Infrastructure Plan, which was heavily criticized by environmental NGOs. **SEA Papers: "Briefly and to the Point"**

The Netherlands Commission for EA (Dept. of Development Cooperation) is trying to put this expression to practice by developing SEA "key sheets": maximum two-page documents aimed at specific user groups explaining the essence of SEA. So far there are four key sheets: a general introduction to SEA, ideas on how to introduce SEA in a country, SEA for poverty reduction strategies, and SEA in the water sector. These key sheets are used in capacity building programmes, specifically to support environment ministries in the introduction of SEA and to convince sector ministries of the value of SEA. The key sheets provide both background information and some cases.

Key sheets under preparation include SEA in conflict sensitive situations, SEA for coastal zone management, and strategic local development planning. **Relationship Between the EU EIA and SEA Directives**

A new European Commission study examines the potential for overlaps between their EIA and SEA Directives. Scenarios are illustrated that may lead to conflicts between the Directives, namely: large projects composed of sub-projects, or at a scale beyond local impact significance; project proposals requiring amendment of land use plans (and thus SEA) before an application to undertake EIA; and plans and programs that when adopted or modified set binding criteria for subsequent development applications.

Among the recommendations to the Commission and Member States is that Member States consider whether coordinated (parallel or joint) EIA/SEA procedures are possible and/or appropriate. Also included is a flowchart to guide authorities in determining whether EIA, SEA, or both, might apply. One long-term option is merging the EIA and SEA Directives into a single law.

## CBBIA Project – Southern African Update

The Southern African Institute for Environmental Assessment (SAIEA) was contracted in mid-2005 to coordinate the southern African component of IAIA's Capacity Building in Biodiversity in Impact Assessment project (CBBIA). SAIEA decided to focus the project on building capacity within decision-making authorities on biodiversity issues.

The project aims to provide a regional guidance document for decision-makers, training materials and a pilot training course. The first output from the study, a draft Situation Assessment, was completed at the end of November 2005. A concerted effort was made to obtain input from the 14 countries that make up the SADC region and to this end a system of ques-

tionnaires, follow-ups and workshops ensured that input was obtained from 11 countries. A key component of the Situation Assessment is the inclusion of 24 case studies which demonstrate both good and bad decisions about biodiversity and the lessons learned.

The conclusion of the Situation Assessment is that there are many problem areas with regard to the way in which biodiversity is addressed in the impact assessment process: firstly there are serious problems in the way that biodiversity information is supplied to the authorities (in the EIA); and secondly there does not appear to be a consistent approach in the way decision-makers make judgements

about, and make decisions on, biodiversity issues. The concepts of ecosystem services and the value of these for society as a whole are not usually taken into consideration at all. Given that a large proportion of the population of the region is fully or partially dependent on natural resources for their livelihoods, subsistence and survival, and that nature-based tourism is one of the fastest growing sectors and comprises a major part of the economy in many countries, the findings of this study are extremely worrying. The need for meaningful guidance for decision-makers on biodiversity issues is thus urgent and CBBIA aims to have a draft document available for comment by April 2006. • Bryony Walmsley • SAIEA • bw@saiea.co.za

## Strategic Action Plan Reviewed

Since its inception in 1999, IAIA's 5-year Strategic Action Plan (for 1999-2004) has formed a central component of Board decisions. It has been regularly reviewed by the IAIA's Strategic Action Planning (SAP) Committee at regular intervals and its progress has been monitored by the Board. To date it has contributed significantly to the direction and increased stability of the IAIA organization, and has been regularly utilized by the Board, Headquarters, and Committees. Considerable progress has been made to date on actions listed in the existing plan.

During the IAIA SEA Prague conference, the SAP Committee met to review the plan as it nears the end of its 5-year life. During the review, the committee came to the conclusion that the time is now right for

- A thorough review of the SAP.
- The closure of some actions in the SAP.
- A revision in the strategic direction of IAIA and its future monitoring through a new SAP.

Central to this review was the conclusion that IAIA has struggled to become the "Global Authority" on impact assessment, as was proposed by the SAP, and whether it remains appropriate for IAIA to continue pursuing this target. The consensus was that IAIA can exert greater influence and play a more significant role as the provider for a "Global Network" for IA. Thus, the goal to become a "Global Authority" was changed to "Global Network."

In Prague, the SAP Committee proposed, and the Board agreed to, a major revision and update of the SAP to form the new IAIA 2005-2010 Strategic Plan. The review will take into account actions still unfulfilled in the original plan and determine whether they should be continued, discarded or amended. This work will be completed by the IAIA06 conference and will be fed into the future business plans for IAIA.

## Launch of the Ireland-UK Branch

The inaugural event of the Ireland-UK Branch was held on 19 December 2005 at the University of East Anglia, England. More than 100 people registered for an event that promised a thought-provoking examination of contemporary challenges facing the impact assessment community. The invited speakers ensured that such expectations were more than satisfied on the day.

The gauntlet was thrown down to Branch members: criticisms were made of public participation practices in environmental assessment, barriers to the integration of health considerations into strategic assessments were highlighted, and delegates were challenged to modify impact assessment tools to promote an ecocentric interpretation of sustainable development. In reflecting the diverse interests of IAIA members, the event also provided valuable insights into the evolving interpretation of

case law and a stimulating review of emerging commercial challenges.

The event was designed to be as inclusive as possible. Students were registered for a nominal fee and the fee for full members of the IAIA covered catering costs only. This was made possible by the generosity of our corporate sponsors.

The event was also open to non-members in an effort to raise the regional profile of IAIA and to recruit new members. Ross Marshall provided an eloquent introduction to IAIA, and outlined future Branch events and international conferences. Positive feedback was received from non-IAIA members, particularly consultants, on the creation of a regional Branch. Yet it is clear that additional initiatives will be required to engage more “decision-makers.”

The next Branch event takes place on 24 March 2006 at Uni-

versity College Dublin, Ireland. Further information on this event will be circulated in due course via the newly created Branch listserv. Future activities will not necessarily take the form of a traditional conference. Consideration will be given to the networking and capacity development requirements of the full spectrum of Branch members, so events might be topic-specific, discursive and participatory, or linked to the activities of other regionally important organisations. ## Heads Up!

The Beerdiversity section of IAIA aims to “Foster” cultural diversity and spiritual values and provide a forum for fermentation of new ideas. Unlike other sections, the Beerdiversity section promotes active fieldwork as well as “Skol”arship and adopts a “bottoms up” approach to sharing the benefits of beerdiversity. The section already has a number of “lager than life” members, including the President-elect, and the cheers of several other sections. We aim to tap the expertise of members and disseminate our findings through both beer-reviewed pubs and the Internet [[www://hopintobeerdiversity.com](http://www://hopintobeerdiversity.com)]. We welcome be “Guinness,” old hands, and those who as yet simply feel a “Carling.”

Sustainable use of beerdiversity is clearly essent-ale. Unlike other aspects of the environment af-

ected by development, however, beerdiversity benefits from increasing consumption, until the “pint” is reached at which carrying capacity is exceeded. We are working hard to identify early warning indicators for critical inebriation thresholds. These reflect the full spectrum of responses, ranging from high-brau debate and increased merriment, to increasingly inarticulate speech, glazed expressions, proliferation of impact assessment jargon and inability to stand—a round. Some practitioners show a tendency to bottle with real-aleity—mild cases are bitter left alone, although in cerveza situations, some incapacity-building may be required.

We are also working to clarify beerdiversity definitions. The draught classification ranges from unspoiled fully-functional beertopes<sup>1</sup> (e.g., Budvar,

Chimay, Batham’s, etc.) to severely degraded, and essentially lifeless systems such as Bud, Miller Lite and Caffreys. Beerdiversity can be appraised at the level of the bottle, the brewery, or multiple outlets requiring a landscape approach, although the “Duvel” is in the detail. GIS (Get In the Stubbies) may be worth considering, especially in identifying longer-term impacts (known as hangovers).

At next year’s conference we propose to move into the spiritual dimension. We request members to bring examples of their local and distinctive specialities to share, to enhance the monitoring base and facilitate follow-up. 


