## EU'S REVIEW OF THE EIA DIRECTIVE

In June 2010 the European Commission launched a wide public consultation in relation to its review of the Environmental Impact Assessment (EIA) Directive, via an online survey being conducted up to 24 September 2010. The objective of this public consultation was to collect opinions from individuals, organisations and public authorities on:

- The overall view on the functioning and effectiveness of the EIA Directive
- The need to amend the EIA Directive
- The possible policy options for review
- The areas to be improved/amended

The Commission recognises that the EIA Directive, adopted 25 years ago, should be updated to reflect changes in EU legislation and policy and case law of the European Court of Justice. The Commission has identified several areas where further improvements are needed. The review should culminate in a new text that will also encompass new policy developments (e.g., in the sectors of climate change, energy and biodiversity) and implementation experiences. The revision will also streamline existing assessment procedures to the extent possible.

The consultation sought views on issues such as the screening of projects for EIA (in view of considerable differences among Member States), the quality of the EIA process (e.g., data used in the EIA, assessment of alternatives), the harmonization of assessment requirements among Member States, transboundary difficulties when activities affect more than one Member State, the role to be played by the environmental authorities, and development of synergies with other EU environmental legislation and policies such as climate change, resource efficiency and biodiversity, which are not sufficiently covered by the Directive in its current form.

The Internet consultation will assist the European Commission in the decision-making process, together with other sources (e.g., experience of the Commission, advice of a group of national experts, and findings of relevant studies to be conducted) when considering options for the review of the EIA Directive.

## INTERNATIONAL GUIDELINES FOR SIA TAKE SHAPE

At IAIA10 in Geneva, a group of approximately 20 people declared an interest in assisting in the development of the International Guidelines for Social Impact Assessment. The International Guidelines are intended to build on the International Principles for SIA by giving more practical instruction about what this new understanding of SIA would mean for SIA practice. The process of developing the guidelines has been given an unexpected boost with support from the Belgium Presidency of the European Union. The Belgium Presidency is keen to promote the increased use of SIA within the EU, and in exchange for assistance in developing SIA in Europe, have agreed to host a workshop to enable the SIA International Guidelines to be developed. This workshop will probably be held in November 2010. A report on the International Guidelines will be given at IAIA11. More information available from **Frank Vanclay** (now based at the University of Groningen) who is coordinating the development of the Guidelines.



## FROM THE PRESIDENT

### Emergency Response Plans

The collapse of the Deepwater Horizon Oil rig in the Gulf of Mexico earlier in the year brought to the fore the subject of emergency response plans. Now that the publicity on the incident has subsided, we can have some sober reflections on the matter. Emergencies and disasters can occur anytime without warning, and as impact assessment practitioners who handle the impacts of various developments or undertakings and their associated risks, we have to deal with emergencies. Preparedness is the key to confronting emergencies.

Risks are associated with most developments and we have to find ways to deal with and avoid risks. Four phases are identified in emergency management:

1. **Mitigation** is the phase that IA practitioners deal with in environmental statements. Mitigation tries to prevent hazards from developing into disasters altogether or reduce the effects of disasters when they occur. In putting forward mitigation measures we should go beyond mitigation and address the other phases of emergency management.
2. **Preparedness** is critical in emergency management. It involves a continuous cycle of planning, organizing, training, equipping, exercising, evaluation and improvement activities to ensure effective coordination and the enhancement of capabilities to prevent, protect against, respond to, recover from, and mitigate against natural disasters, acts of terrorism and other man-made disasters.
3. **Response** covers mobilization of the necessary emergency services in the disaster areas.
4. **Recovery** tries to restore the affected area to its previous states.

As we go about our professional activities, we should not lose sight of emergency response management issues but ensure that measures and procedures are put in place for emergency situations.

## INCORPORATING ENHANCEMENT OF POSITIVE IMPACTS INTO ENVIRONMENTAL ASSESSMENT PRACTICE?



# DCGIS BECOMES OFFICIAL METHODOLOGY IN ITALY FOR GIS-BASED IMPACT ASSESSMENT

The Dynamic Computational GIS (DCGIS) is an integrated advanced methodology for environmental impact assessment of projects and plans, based on application of structured GIS language and compliant with US EPA and ASTM risk assessment standards and criteria defined by WHO for HIA. The main characteristics of this methodology are concerned with (1) cumulative impact assessment and (2) innovative participation and communication of advanced modeling results into simple GIS-based language. The adoption process of DCGIS into official policy framework has been successfully supported by IAIA members has included the participation of twelve Provincial Municipalities and local stakeholders. The project started in 2007 and after three years of testing, applications and validations were officially adopted on 26 June 2010 with Regional Decree N. 11317/10 for environmental screening of waste treatment and disposal plants (representing one of the most critical kinds of procedures (EIA/SEA) in terms of participation and acceptance with local communities).

The main goals of this project are (1) to improve effective and practical use of GIS supported by a structured language for addressing impact conditions (baseline cumulative impacts frame) enforcing communication levels between institutional and private players, (2) to provide an integrated approach based on modeling and monitoring application (predictions and measurements integrated into official GIS based procedure), and (3) to enforce the participation level during the authorization phase of projects.

This official step has been reached thanks to a cooperation of researchers, institutional and private players and represents an important phase of that strategic challenge to enforce an iterative dialogue between scientific and administrative-governmental worlds.

In particular, this system represents a screening frame for any instances of EIA and SEA and will be proposed to other nations.

In response to increasing interest in the cultural heritage component of EIA and SEA, IAIA has created a Cultural Heritage Section. Cultural heritage is an integral facet of impact assessment, but has received less attention than the biophysical and social components. The importance of culture in development is recognized in the policies of international and regional financial institutions, bilateral aid agencies, and the laws of national governments. Guidance material and tools are available for improving coverage of cultural heritage. Since 2005, several IAIA annual conferences have included sessions and training courses on cultural heritage in impact assessment.

At IAIA11 there will be a meeting to discuss the Cultural Heritage Section, the Key Citations on Cultural Heritage in Impact Assessment, and a draft of Best Practice Principles. 
